## SOLICITORS, CANVASSERS AND/OR PEDDLERS RULES

- 1. Solicitors are not permitted to go door-to-door before 8:00am or after 9:00pm daily.
- 2. Do not approach homes displaying "No Solicitors or Peddlers Invited" or "No Trespassing" or any other similar notice indicating that the occupants do not wish to be solicited or otherwise disturbed.
- 3. When asked to leave the residents premises, solicitors must comply immediately. Aggressive behavior will result in revocation of the solicitation license.
- 4. You must carry the Solicitor/Canvasser/Peddler license issued by the City of Ellis at all times and present to residents, if requested.
- 5. Your business identification (ID Badge, jacket, uniform) must be visible at all times.
- 6. The license does not imply endorsement or approval by the City of Ellis of the goods and/or services you represent. Any solicitor implying endorsement or misrepresenting themselves and/or business will result in revocation of the solicitation license.
- 7. A license fee of \$50.00 will be collected at the time of issuance of the license.
- 8. An investigative fee of \$25.00 will be collected at the time of filing the application for non-county residents.
- 9. The license will be good in the City of Ellis for a period of six months from the date of issue.

## **DENIAL, REVOCATION OR SUSPENSION OF LICENSE**

The City Clerk and/or Chief of Police in the City of Ellis may deny any application or may revoke or suspend for a period not to exceed 30 days, the license issued under City Ordinance #1488, for any of the following causes:

- 1. Fraud, misrepresentation or false statement contained in the application for license.
- 2. Fraud, misrepresentation or false statement made in the course of carrying on the business.
- 3. Any violation of this ordinance.
- 4. Conducting business as defined in Section 1 of City Ordinance #1488 in an unlawful manner or in such a manner as to constitute a breach of peace or to constitute menace to the health, safety or general welfare to the City.
- 5. Conviction of crime of theft, larceny, fraud, embezzlement or any felony with two years prior to application date.

Notice of denial, revocation or suspension of a license shall be given in writing to the applicant or mailed to his or her last known address and the City Clerk shall set forth the grounds of such denial, revocation or suspension.

## **APPEAL TO GOVERNING BODY**

In the event of a denial, revocation or suspension of license:

- a. Any person aggrieved by the action of the Chief of Police or City Clerk in the denial, revocation, suspension of a license as provided in City Ordinance #1488, shall have the right of appeal to the governing body.
- b. Such appeal shall be taken by filing with the City Clerk within 14 days after notice of revocation, suspension or denial of the license has been given to or mailed to such applicant's last known address and setting forth the ground for appeal.
- c. The governing body shall set a time and place for a hearing on such appeal and notice of such hearing shall be given to the applicant in the same manner as provided herein for notice of denial, revocation or suspension.
- d. The decision and order of the governing body on such appeal shall be final and conclusive.
