Hoping for the Best, Preparing for the Worst

Active Shooters: the worst possible incident that can happen in our great nation. Law Enforcement agencies across our country prepare for these situations and the Ellis Police Department is no different. In August, the Ellis Police Department hosted active shooter training at the Old Ellis High School campus, located in the 400 block of West 11th St.

Attending this training were several area Law Enforcement agencies: the Ellis County Sheriff's Office, WaKeeney Police Department, Trego County Sheriff's Office, and the Kansas Dept. of Wildlife and Parks. Officers received training on moving towards and through an active scene, establishing a clear chain of command, requesting additional resources, and neutralizing the threat that is present on scene. Officers also received some medical training that covered treating injuries to victims on scene, as well as themselves. Solo, duo, and team response scenarios were also covered.

It is very important to us as a community that we take these situations very seriously and report suspicious activity or strange circumstances. If something seems off or doesn't feel right, report it, even if you think it's nothing. The Ellis Police Department takes very seriously the moral duty to protect the innocent from harm. We hope that tragedy never strikes in our little town, but we stand by, ready to act if called upon for these situations.



Lead and Copper Survey

The City of Ellis is still in the process of collecting all the Lead and Copper Pipe Surveys that were sent out with utility bills in the last year. We wish to thank the several hundred people who have returned their survey back to the City.

For those who have not returned their survey, in the next few weeks, the Public Works department will be going door-to-door to help the owner, renter or business complete the survey. We will also have to go door-to-door for those who returned their survey and were not able to identify what type of material their pipes are.

These surveys are mandatory from the State of Kansas and the EPA. They are to be filed with the State of Kansas by October 24, 2024, along with our proposed plan to start a lead service line replacement program. All lead lines are to be removed by 2034. This will be a very expensive undertaking.

The surveys are important in not only helping us determine which lines will be replaced, but when completed, should help us with State and Federal grants to help pay for it. Your cooperation in this endeavor is very much appreciated!



Utility Rate Changes (Comparison of Current to New)

One of the key considerations during the budget process is determining whether current utility rates can continue to cover the expenses required to maintain each utility. The City manages three main utility funds: water, sewer, and sanitation (trash). According to State Statute, municipal utility funds must be self-sustaining, meaning that the revenue generated must

be sufficient to cover the expenses of each fund. In August 2016, the Council adopted Ordinance No. 1407, which provides for automatic 2% annual utility rate increases. This measure aims to address inflation gradually, reducing the need for larger, more sudden rate hikes. The percentage can be adjusted by Resolution if necessary.

During budget preparation each vear, this Ordinance is reviewed to determine whether the 2% increase will be sufficient for the upcoming year. After analyzing the utility funds, the Council decided to move forward with the automatic 2% increase in water, sewer, and sanitation rates for the next budget. The new rates will take effect with the November 1, 2024 utility bills, covering usage from September 10th to October 10th.



Every Vote Counts!

Registered voters will head to the polls to elect representatives for our local government on November 5th. This year, three City Council seats are up for election. The positions are currently held by Council members Jolene Niernberger, Martin LaBarge, and Kellie Crnkovich. Incumbents Jolene Niernberger and Martin LaBarge are running for re-election, joined by two additional candidates, Dava Gaschler and Trevor LaBarge, all vying for the three open seats.

Polls will be open from 7:00 a.m. to 7:00 p.m. at the Ellis VFW, located at 813 Jefferson, next to City Hall. Make sure to get out and vote on November 5th to let your voice be heard!



Flooding in Ellis Submitted by Steve Homburg, Certified Floodplain Manager

Parts of the City of Ellis are in a Special Flood Hazard Area (SFHA). These areas are susceptible to flooding from Big Creek or the tributaries of Big Creek. If you live in the SHFA, Flood Insurance is a good investment. To see if your house is protected from flooding, contact your insurance agent. For renters and home owners, contents insurance is available for flooding. There is a 30-day waiting period for the policy to take effect, so waiting for a flood to occur, then buying a policy will not work.

If there is water running across a street or road. Turn Around, Don't Drown is a message that could save your life.

It is a good idea to store any valuable records and possessions in a water tight container.

Always check at the Public Works Office before any building or improvements are started to see if you need a building permit and a floodplain permit.

Keeping trees and other brush cleared in the natural drainage of the town keeps the water flowing and stops it from backing up and causing a rise in the water level.





Grant Funding Secured for Mural Project

In June, the Council received exciting news for the mural project! The Clerk's office applied for grants to help cover the project's \$20,000 total cost. Applications were submitted to the Office of Rural Prosperity Rural Mural & Public Art Grant Program and the Dane G. Hansen Foundation. The City of Ellis was awarded grants from both organizations, totaling \$16,500, which will go toward the project. The City will be responsible for the remaining \$3,500 balance. Mindy Allen, the artist who recently painted the elevator in Inman, KS, is scheduled to complete the mural from late

September to early October this year. We eagerly anticipate the new mural on the south side of the municipal building.

Understanding your Flood Risk (ASFPM Newsletter)

Developed by ASFPM in 2022, with financial support from FEMA, this interactive website provides users with the information they need to understand and mitigate their flood risks. **Now** with more than 45 flood mitigation strategies, ReduceFloodRisk.org delivers detailed guidance, complete with photos, graphics, and links to additional resources, empowering individuals to make informed decisions.

To get started, simply go to ReduceFloodRisk.org, answer a series of five quick questions, and receive a detailed list of mitigation options recommended to reduce flood risk for their specific property type. The curated results can then be filtered and sorted by key attributes, such as cost,

complexity, and level of required maintenance, making it easy for people to find solutions that fit their needs and budgets. Additionally, the site offers helpful resources on flood insurance, financial assistance, and expert contacts, all available without needing to create an account.



Sewer Cleaning

Recently, Mayer Specialists was in town cleaning a portion of our City sewer lines. We want to remind the community that certain items should never be flushed down the toilet, as they cannot be properly treated by the City's wastewater system. Flushing these items can cause them to clump together and block the sewers, leading to potential flooding in homes and yards. This not only causes significant inconvenience for families but also results in costly repairs for the City.

This is a growing issue in many cities, but you can help protect our community! Please DO NOT flush the following items: cleaning wipes, baby wipes, paper towels or feminine hygiene products. Even

wipes labeled as "flushable" should be disposed of in the trash can.

Let's work together to protect our sewer lines and wastewater treatment plant. The only things that should be flushed down the toilet are bodily fluids, fecal matter, and toilet paper. Everything else belongs in the trash!



Positivity in Our Community!

What a Summer! As the kids head back to school, I reflect on all the positive things that have taken place in our city in the first seven months of this year.

The Ellis School Buildings have been transformed with much needed remodeling and upgrades that the district bond has provided.

Citywide concerns - Ellis is addressing the housing shortage by using the remaining TIF funds on the south hill area to get several street extensions and infrastructure in place. This will immediately provide 12 building lots available for new housing starts. More lots will be available later as the residential area grows to the south and east when funds are secured for expansion. The City is also aware of the water pressure issue in the south area of town and has contacted an engineer to investigate and provide a plan for a pressure booster station for that area.

NRP or Neighborhood Revitalization Plan was approved and is available to all Ellis citizens.

The downtown development group (Grow Ellis Downtown) is investigating ways and funding to improve our downtown district and attract businesses downtown.

The campground has been very busy this season. New facilities/improvements for the south side of the camping area include a second bathhouse and other improvements. Funds have been secured and construction should begin shortly with a spring date for final completion.


The city continues with the annual street maintenance program. Crack sealing and chip sealing are important to the preservation of the streets. The Council has recently set funds in the 2025 budget for the improvement of 2nd Street to enhance current and future business prospects in the northwest part of town. The council and staff are always aware and working to secure grants to help with street improvements and replacement. Street repairs in some areas will be dictated by the water and sewer issues under the driving lanes that need attention before replacing the street can be accomplished.

The Trego Waterline Project continues to move forward. Property owners in Trego and Ellis County are being contacted regarding the easements needed to continue the process. The Water Project will help blend water to improve the quantity and quality of water for Ellis citizens for many years to come.

Have you noticed that 3 new houses are under construction in town right now? Let's continue to progress in a positive manner.

Preparing for Winter

As outdoor temperatures cool, it's only natural to warm things up inside. Before you flip the switch on the heater, take a minute to complete your fall safety checklist.

When you turn your clocks back, replace the batteries in all smoke alarms and carbon monoxide detectors. Make sure your fire extinguisher is fully charged, and within the expiration date. If you don't have a fire extinguisher, get one!

Make sure everyone knows where the fire extinguisher is stored and how to properly use it. Then, develop a fire safety plan and escape route for your family. Teach everyone how to stop, drop and roll.

Before it gets frigid, turn the heating unit on to ensure it is working properly. To reduce the risk of furnace fires, regularly replace furnace filters and keep all areas around the furnace and burner clean and unobstructed. Combustibles should be at least six-inches away from the vent pipe, and never close off more than 20% of heat registers.

If you have a fireplace, have a professional clean and inspect your chimney. Use a fireplace screen, guard, or glass doors to keep hot ash and sparks contained. Store extra wood, and other types of combustible

materials, at least five feet away from your fireplace, and never leave a fire unattended. Burn seasoned hardwoods, such as oak, and keep fires small. When building a fire, strategically place logs on a metal grate at the back end of your fireplace using kindling





Clean your gutters, downspouts, and remove all leaves and debris from the perimeter of your space. Never park your vehicle over a pile of leaves. Heat emitted from your car can ignite the leaves, destroying your vehicle and all things around it. After every load of laundry, clean the dryer vent. On a regular basis, clean your toaster and/or toaster oven to remove crumbs and leftover food.

Most of these recommendations seem like common sense, right? But, the busier we get, the less fire safety in the forefront. When the clocks roll back this fall, take time to prepare your home or business for a fire-safe fall and winter season.



🚌 When Do I Call 911?

"When do I call 911? I'm not sure if this is an emergency."

If you are unsure if you are reporting an emergency, it is best to call 911. Examples of emergency situations are as follows:

- ★ You have been the victim of a crime
- You have witnessed a crime
- You have either witnessed or been involved in a traffic accident
- You or your neighbor's house is on fire
- You or someone else is currently experiencing a medical issue, and you need emergency medical services
- Your child has gone missing

Examples of situations that require police response and aren't considered emergencies that should be reported to the non-emergency line are as follows:

- ★ There is a dog running at large that is not being aggressive
- ★ You have questions about city ordinances
- You need to request a welfare check on someone that didn't show up to work today
- Employment requires you to be fingerprinted
- ★ You would like to request a civil standby

These are just a few of examples of situations that should be reported to the non-emergency line at (785) 625-1011.

No matter which reporting method you choose, a dispatcher will answer the phone. They will begin gathering relevant information from you and get the call for service dispatched appropriately. The biggest help that you can give them is to answer their questions completely and calmly. Our dispatchers are trained in Emergency Medical Dispatch (EMD). They may give you instructions on performing CPR, and will coach you through performing CPR, should the situation require it. The moment all required information is gathered, the call for

service is sent to Law Enforcement, EMS, or Firefighters; who will then respond to the scene.





We also want to acknowledge our five Water Safety Instructors - Grace Brull, Toby Honas, Ava Reed, Mason Rohleder, and Maleah Vine - who led two sessions of Red Cross swimming lessons and offered private lessons both before and after regular pool hours. This season, the staff provided more private swim lessons than they did in 2023, helping to ensure that our youth have the skills they need to stay safe in the water.

Unfortunately, Mother Nature forced the pool to remain closed for three days this season. The storms and cooler weather affected our 2024 pool attendance, with 2,859 patrons visiting, down from 3,487 last year. On a brighter note, water aerobics saw a surge in popularity, drawing 192 participants compared to 117 last year. We also hosted 7 pool parties!

Scam Awareness

Every year, the Ellis Police Department takes numerous calls of our community members being scammed. In most instances, scammers tell our community members that they have won an exorbitant amount of money or that they have warrants for their arrest. Remember, if it plays to your emotions or sounds too good to be true, it is. In some instances, scammers try to gain access to your personal information via hacking your accounts.

Here are some steps that you can take to protect your personal information and your accounts:

- 1. Use STRONG passwords that don't consist of things like your pet's name or your date of birth.
- 2. Change your passwords frequently, or set up two-factor authentication (2FA) on your accounts. Most social media accounts offer 2FA.
- 3. Never store your personal information in a place where it can easily be found.
- 4. Set up a recovery email that is linked with your accounts, so that you can use that email to recover an account that was hacked or stolen from you.

Another common scheme is through text messages. A NO! NO! phone number or email address will text your phone informing you that a package that was scheduled for delivery was stopped due to an issue with either your payment information or your Amazon account. Another common text that goes out requests the community member pay an invoice for an anti-virus software that they didn't purchase. The text message will ask you to follow a link to clear up the issue. Following that link can potentially leak your personal information to the scammer that sent you the message.

The most recent scam that has hit our area is called a "Brushing Scam." To read more information on this scam, you can visit the United States' Postal Service Inspector website at:

If you receive scam calls or strange text messages, the easiest way to get them to stop is to not reply. Most modern phones also have the ability to have calls from numbers not in your contacts list sent straight to voicemail. If you receive a large number of scam calls, consider enabling this feature to alleviate some of the headache that comes with scammers trying to get your information. If you have any questions about suspicious calls or texts you have received, please contact Ellis County Communications via the non-emergency number at (785) 625-1011 and ask to speak to an Ellis Police Officer about the suspicious activity. You will be transferred to an officer who can take a look at the calls or messages for you and advise you if you are being scammed.

The following responses have been printed exactly as the candidate submitted.

What position are you running for?

Jolene Niernberger

City Council. I currently serve on the Council, the Planning Commission and Board of Zoning Appeals, Housing Authority, Ellis Alliance, Senior Advisory Committee and the Kansas Community Empowerment Program (Ellis PRIDE).

What do you think are your qualifications for this position?

I am Jolene Niernberger, candidate for a position on the Ellis

My qualifications include my experience as a Council representative, my background in grant management and community outreach, and my commitment to service. I attend League of Kansas Municipalities (LKM)-sponsored conferences, have taken Leadership Academy training seminars and served on the LKM Finance and Taxation Policy Committee.

What do you think are the most important issues facing the City during the next two years, and how should they be dealt with?

An adequate water supply is critical for our survival and growth. Our water expansion plan is progressing. We have secured water rights that assure our access to an adequate supply of quality water for our citizens. We continue to meet our fiscal obligations and requirements to ensure our utilities (water, wastewater and sanitation operations) remain in compliance with federal and state mandates, enabling us to provide efficient, cost-effective services.

We adhere to our comprehensive plan for street maintenance. I support continued investments to annually replace, improve and maintain our city's street, water and sewer infrastructure.

The role of government is to deliver basic services: ensure public safety, provide for the health and welfare of our citizens, economic development and contribute to quality of life projects. To continue to provide these basic services we must increase our tax base with commercial and residential development. An expanded tax base is also necessary to support our schools, maintain our parks, continue the campground expansion project, and support our recreational programs.

What do you think are the most important issues facing the City during the next two years, and how should they be dealt with?

The City of Ellis infrasturcture has always been the most important to me. Within the City infrasturcture is water, streets, and sewer. We are currently in the process of bringing the Trego water line project to the City of Ellis to tie end to the water treatment plant. This is to ensure not only future water supply but also improve the quality of our water by blending it with our current water wells at the water treatment plant. Another project that is planned is a pressure station on the south part of Ellis and that is to improve the water pressure for the existing and future homes to be developed. Our streets, we have plans to replace 2nd St from Washington St. west to Dorrance St. This is to accomidate the truck route traffic for the commercial businesses there now and for future commercial development in the future. Then for 6th St. the Monroe intersection and approximately 70 ft. to the west. 6th St. is also a high traffic street, along with a school and church there, and also with our continued maintance on the rest of our streets to repair and patch when water leaks occur, break out, also sealing cracks along with street sealing in different sections of town.

And the sewer plant, this includes the lift stations, and sewer lines. They also under go general maintenance and repairs to keep the sewer system running properly.









2025 Budget Preparation

Normally, at the time of the September newsletter, I have a report on the approved budget for the next year. This year, however, is not the case. Budget preparation for the 2025 budget was quite different than years' past.

For one, the City's assessed valuation increased almost \$3 million dollars due to the expiration of the Tax Increment Financing (TIF) district. The City will make the final payment on the TIF bonds in October 2024.

Also, back in 2016 the City refinanced the 2006 Revenue and General Obligation bonds for the Water Treatment Plant. The bonds will be paid off two years early with the final bond payment in October 2024 as well. With the payoff of that debt, the "bond fee" on the utility bills will no longer be assessed. However, before everyone gets too excited, a bond fee will once again be assessed when payments for the Trego well project start. Construction hasn't even started on that project so we don't anticipate the bond fee to return until at least mid to late 2025. At this time, the amount of the returning bond fee is unknown. The fee is dependent on the actual cost of the project and how much the City will have to finance after applying designated cash reserves.

Another consideration for the 2025 budget is that the Campground Improvement Project should be completed next year. That project adds an additional bathhouse and new playground equipment on the south side of the campground. The City received a Community Development Block Grant to help pay a portion of the project.

The City will hold its Revenue Neutral Rate and Budget Hearings on September 3rd at 6:00 p.m. in Council Chambers at City Hall. I will have a full update for the December newsletter regarding the 2025 budget.
