Big Shoes to Fill

It's been a while since I last submitted an article to the Town Crier. For the past few years, Tim Kohlrus has been not only writing the articles, but also taking on many behind-the-scenes tasks to keep the Fire Department running smoothly. Recently, Tim reached a significant milestone in his career and decided to retire after serving twenty years.

It's truly remarkable to witness a young person with no prior experience joining the department and growing into a pillar of the organization. The term "hero" has been overused and lost its true meaning in recent times, but Tim Kohlrus is a true hero. In June 2012, without hesitation, he rescued two people trapped on the roof of their vehicle, surrounded by the rapidly rising water of Big Creek. Despite my initial plan of swallowing all the water in Big Creek and then having the victims walk back to the bank, Tim's idea to swim to them with a rope, grab them, and be pulled back by the people on land proved successful.

Tim's dedication and training have not only saved lives but also helped bring back victims of cardiac arrest. He's also rescued trapped people from wrecked cars and even ventured in to burning buildings, searching for both people and pets. Additionally, Tim has been an enthusiastic teacher, sharing his skills with others who have no prior experience but a desire to learn. New Online Utility Payment Option now Available for Ellis Residents

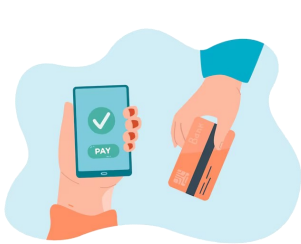
We're excited to announce that residents can now conveniently pay their utility bills online through our official website at ellis.ks.us using KanPay. This new payment option makes managing your bills easier and faster, right from your computer or mobile device.

Here's what you need to know about the new online payment service:

- **Credit or Debit Card Payments:** A service fee of 2.5% of your total bill will be applied.
- **eCheck Payments:** A flat service fee of \$1.50 per transaction.

Note: These fees are the same as those charged when paying over the phone or in person at the City office, ensuring consistency no matter how you choose to pay.

To pay your bill online, visit ellis.ks.us > **City Office tab** > **Resident Info/Pay** and click on **Online Bill Pay** to access the KanPay portal. **When entering the Zip Code, it must be the Zip Code on file with your credit card company, otherwise, your payment will be rejected.**



In 2026, the City of Ellis will upgrade its accounting and utility billing system to Edmunds GovTech. This upgrade comes as our current software reaches its end of life and is designed to provide enhanced functionality and a better user experience.

One key feature of the new system is the integration with Edmunds GovTech's online utility bill payments. This service will allow payments made by residents to automatically sync directly with their utility accounts, eliminating manual processing and reducing errors.

Once the new system is in place:

- Residents will enjoy seamless payment posting to their accounts.
- The City will have improved tracking and reporting capabilities.
- The overall payment process will be more efficient and convenient for both residents and City staff.

With this upgrade, the online payment fees will adjust slightly as follows:

- **Credit or Debit Card Payments:** The service fee will increase to 2.95%.
- **eCheck Payments:** The flat fee will increase to \$1.95.

Deer Season on the Roads!

Autumn in Kansas means beautiful sunsets, great weather and a sharp increase of vehicle vs. deer accidents. From October through December, deer are more active due to mating season and changes in food sources, making them more likely to cross roadways, especially at dawn and dusk.

What to watch for:

1. **Peak Hours** - Deer are most active in the early morning and evening.
2. **Herd Behavior** - If you see one deer, there are usually more around it.
3. **Rural and Wooded Areas** - Pay extra attention in areas with tree lines, creeks, and fields.

Safety tips:

1. **Slow down** in known deer zones and use your high beams when possible at night to spot eye shine in the ditches along the roadway.
2. **Don't swerve!** It is much safer to brake firmly and stay in your lane than to swerve into oncoming traffic or a ditch.
3. **Buckle up!** A seatbelt can reduce injury if a collision occurs.
4. **Stay alert** after a near miss. Deer travel in herds, if you miss one, there are surely more nearby!
5. **Report accidents promptly.** If you are in an accident and are un-injured contact Ellis County Communications at (785) 625-1011 to report the accident. Use 911 if you are injured!

By staying alert and knowing what to look for, we can reduce collisions and keep both drivers and wildlife safer this season!

Downtown Historic District Update

The City of Ellis has received notification from Hernly Associates, Inc. that fieldwork is now complete and all Kansas Historical Registration Information entries have been finalized. They prepared the rough draft and plan submitted it to the Kansas Historical Society for review by August 31, 2025.

In addition, Hernly Associates, Inc. consulted with Bethany Falvey of FEMA to gather information on flood regulations as they apply within a Historic District. This information was included in our submission, as much of the downtown area lies within the floodplain.

We look forward to receiving feedback from the Kansas Historical Society regarding our community.



Revenue Neutral Rate Hearing

On September 2nd, along with the regular Council meeting, the City will hold its Revenue Neutral Rate (RNR) Hearing and Budget Hearing for the 2026 budget document. The RNR Hearing is required as part of the Tax Transparency Act under Senate Bill 13. The Act prohibits municipalities from levying a single dollar more of property tax than the prior year without a Revenue Neutral Rate hearing. If the City would not hold this hearing, and levy more tax dollars than the dollars levied last year, the City would be required to refund taxpayers every dollar received in excess of last year's levy.

The Revenue Neutral Rate is a calculation dividing the previous year's property tax raised in dollars by the current year's estimated assessed valuation. For the 2026 budget, the City's RNR is 72.302, compared to a 2025 final adjusted mill levy rate of 75.228.

The City's estimated valuation increased for the fifth year in a row, from \$14,629,310 to \$17,612,539. The value of one mill for the 2026 budget is \$18,326, which means that every mill assessed generates approximately \$18,326 in tax dollars to fund the 2026 budget.

The Governing Body participated in multiple budget work sessions. The City prepared the budget, maintaining the same mill levy rate as 2025. The City has not increased the mill levy for the last five years. Under the 2026 budget, the City will be able to maintain the same level of services to residents; however, many capital improvements and equipment purchases will have to be delayed.

The City Council appropriated 3.86 mills (\$70,750) in aid to the Ellis Railroad Museum, Walter P. Chrysler Boyhood Home & Museum, Ellis Alliance, Ellis Community Foundation, Options, Ellis Recreation Commission, Grow Hays, Big Brothers Big Sisters, the Center for Life Experience, and the Heartland Community Foundation. As required by Charter Ordinance, 4 mills were levied for the Ellis Public Library (\$80,825). In addition to the required 4 mills, the City appropriated another 0.65 mills (\$12,000) to the Library for capital improvements, personnel, and programming.

The City was able to fund operations of the utility funds within the automatic 2% rate increase as authorized by Ordinance 1407. This ordinance has allowed Council to make small inflationary increases rather than large rate jumps. The City has the authority to implement a higher rate increase by approving a resolution; however, the automatic 2% increase was sufficient to provide the same level of service.

The Tax Transparency Act shortens an already intense and extensive process. Preparing the annual budget is always an intense and challenging process, requiring a great deal of time, thought, and collaboration. Both City staff and the City Council have worked diligently to ensure a fair and balanced budget that meets the needs of our community while remaining fiscally responsible. This is no small task; balancing essential services, future planning, and financial constraints takes careful consideration and tough decision-making. We commend the Council for their dedication, attention to detail, and commitment to doing what's best for the residents of Ellis.

Utility Rate Changes (Comparison of Current to New)

One of the key considerations during the budget process is determining whether current utility rates can continue to cover the expenses required to maintain each utility. The City manages three main utility funds: water, sewer, and sanitation (trash).

According to State Statute, municipal utility funds must be self-sustaining, meaning that the revenue generated must be sufficient to cover the expenses of each fund. In August 2016, the Council adopted Ordinance No. 1407, which provides

for automatic 2% annual utility rate increases. This measure aims to address inflation gradually, reducing the need for larger, more sudden rate hikes. The percentage can be adjusted by Resolution if necessary.

During budget preparation each year, this Ordinance is reviewed to determine whether the 2% increase will be sufficient for the upcoming year. After analyzing the utility funds, the Council decided to move forward with the automatic 2% increase in water, sewer, and sanitation rates for the next budget. The new rates will take effect with the November 1, 2025 utility bills, covering usage from September 10th to October 10th.

NIXLE Alert System - Stay in the Know!

Did you know the City of Ellis has a weather alert system? Yes, NIXLE, this system links with the National Weather Service for weather alerts and advisories. Residents have an option to set "silent" hours, in which notifications will not be sent out during those hours. In order to avoid "text fatigue", we will only use the "Alert" notification for those notifications that warrant an immediate response. Once you set up your Nixle account, you can modify your settings at any time!

How to sign up:

There are two ways to sign up if you would like to OPT IN to receive notifications.

☆ TEXT "ELLISCITY" to 888777 and follow prompts

☆ Go to www.nixle.com and click on "Resident Login", then click on **GREEN** "Sign Up" box.

Even if you sign up through text, you will still need to go to www.nixle.com to set up an account in order to select notification preferences. On the "Settings" tab, mark the box for City of Ellis. On the "Locations" tab, we strongly encourage everyone to input your address. This will enable us to ONLY send out messages relevant to your neighborhood, i.e. waterline breaks, police activity, etc. Residents have the ability to input multiple addresses for work and home.

There are THREE types of notifications the City will use – Alerts, Advisories, and Community

☆ ALERT – time sensitive notifications that need immediate attention – severe weather warnings, water leaks in your area, etc.

☆ ADVISORY – "need to know", but less time sensitive – weather advisories, street closures, etc.

☆ COMMUNITY – announcements, NOT time sensitive – event reminders, community updates, etc.

NOTE: When setting up your account in Nixle, if you click "Email" notifications on the Settings tab, "Advisory" and "Community" notices will ONLY come through email and not text. "Alerts" are ALWAYS sent to all devices.

Last Grass Pickup

After that date, the Sanitation Crew will **NOT** empty the green grass carts until next April. You may store the grass cart at your residence until the next mowing season.

If you are still mowing grass after October 28th, please place the **BAGGED** grass clippings in your trash cart or take them to the compost pile.

During the winter season, grass carts cannot be used as extra trash carts. If you have more trash than your regular cart can hold, please call 785-726-4812 to arrange a special trash pickup.



Shorter Days, Longer Nights

As autumn approaches, the amount of daylight that we receive every day grows shorter. That means that many of us are commuting to and from different activities in the dark or during low light conditions. Reduced light can make it harder for drivers to see pedestrians, cyclists, or even other vehicles.

For Pedestrians and Cyclists:

- **Be Seen** - Wear bright colors or reflective clothing. A simple reflective armband or headlamp can make a huge difference.
- **Use Lights** - Cyclists should follow all applicable Kansas Statutes in regard to usage of lights. Kansas Statute states that cyclists *shall* use white lights mounted to the front of the bike when riding in dark conditions, just like you would behind the wheel of a car. Cyclists are also required to have *at least* a red reflector to the rear- but it is encouraged that they have a red light displayed.
- **Cross Safely** - use crosswalks and wait for drivers to stop. Avoid crossing near parked cars.
- **Stay Off Devices** - Keep your head up and eyes on your surroundings. Consider only using one earbud so that you can hear the world around you if listening to music.

For Drivers:

- **Slow Down in Neighborhoods**
- **Check Your Headlights** - Clean, working headlights are your best friend!
- **Watch for Glare** - Autumn sunsets can cause blinding glare during evening commutes. Keep sunglasses in your vehicle and make sure your windshield is clean.

Whether you're behind the wheel, on foot, or on a bike; staying visible and alert helps prevent accidents. A few extra seconds of awareness can save a life!

Cyber Shopping Safety

As holiday seasons approach, gift giving is a time-honored tradition that many families participate in. Unfortunately, scamming you out of your hard earned money is another tradition that is honored by online criminals. Criminals take this time to create seemingly legitimate online storefronts that can trick you into revealing your personal information. When shopping online do the following:

- Use trusted retailers and avoid deals that seem too good to be true. Check for "https" in the website's address and look for customer reviews. You can verify most major online retailers through the Better Business Bureau or via Google Reviews indicating that the person is a verified buyer.
- Don't click links in unsolicited messages. If you get a shipping notice, go to the carrier's official website or app to check tracking on your packages.
- Secure your accounts! Use strong, unique passwords and enable two-factor authentication.
- Review your bank statements and credit/debit card activity often so you can catch suspicious charges quickly.
- If you are being pressured to act on a purchase fast, it might be a scam! Scammers play on a sense of urgency to bypass your good judgement.

A few extra minutes of caution or doing some homework on a retailer can help save you a lot of headache. If you have been a victim of a scam, please contact the Ellis Police Department.



Is Your Dog an Escape Artist?

We often receive calls about dogs running at large. If your pup is properly tagged with a City dog tag, the Police Department will do their best to contact you before taking your dog to the pound.

However, if your dog is impounded, fees will apply:

- Admin Fee (one-time): \$10
- Vaccinated Dogs: \$20 per calendar day
- Unvaccinated or Dangerous Dogs: \$30 per calendar day

Important: If your dog is not legally tagged, you'll need to provide a valid rabies certificate and purchase a tag before your pet can be released from the pound.

Dog Tag Costs:

- \$5 for spayed/neutered dogs
- \$10 for intact dogs

Dog tag renewals begin January 1st each year and are penalty-free until February 28th. Starting March 1st, a \$2/month penalty applies. If you have questions, call the City Office at 785-726-4812 to keep your furry friend safe and legal!

Sales Tax Ballot Question

On November 4, 2025, Ellis residents will decide whether to **renew** the current one-cent City sales tax that helps support our community's water supply and distribution systems. This sales tax is currently used to make payments on the Water Treatment Plant, which was built in 2006.

If voters approve the renewal, the tax would continue from 2026 through 2036, and at that time, residents would need to vote again to decide if it should be extended further. The General Obligation Bonds used to finance the Water Treatment Plant are scheduled to be paid off in 2048 and 2050.

If the renewal is not approved, the City would need to raise revenue through other means to meet the bond payments. Choosing a sales tax over a property tax increase or higher utility rates allows the cost to be shared by all who visit and shop in Ellis, not just local residents.

On September 2, 2025 the Ellis City Council will Vote to approve Resolution No. 630, submitting the sales tax proposition to the County Clerk. Below is an excerpt from the Notice of Special Question Election.

The proposition shall appear on the ballot as follows:

Shall the following be adopted?

Shall a one percent retailer's sales tax be imposed on qualified purchases within the City of Ellis, Kansas, with the revenue generated therefrom to be either directly or indirectly applied to improvements in the municipal water supply and distribution systems?

City Council has not yet determined if the election will take place at the physical polling location (Ellis VFW) or through "mail-in" ballots. We will keep you informed of their decision once a decision has been made.

The Campground Committee is excited to share that Phase 2 of the expansion project is now complete! The Kansas Department of Commerce recently conducted the final inspection, and the closeout hearing was held on September 2nd.

This phase included the installation of a new ADA-accessible playground and a pre-fabricated bathhouse. The bathhouse is now open for use, and the playground has already been enjoyed by many youth. If you haven't had a chance to visit yet, we encourage you to stop by and see the new additions. We've received wonderful feedback from travelers who remark on how fortunate Ellis is to have such a well-maintained, city-owned campground.

We would also like to extend our sincere thanks to the organizations whose generous support made this project possible. Funding was provided by the following:

- **CDBG** – \$334,216
- **Dane G. Hansen Foundation** – \$45,000
- **Patterson Family Foundation** – \$40,000
- **Heartland Community Foundation** – \$7,059
- **Community Foundation of Ellis** – \$1,000
- **Midwest Energy Community Fund** – \$1,000

This totaled \$428,275 in grant funding. With the final project cost coming to \$491,402 (after two change orders), the City of Ellis contributed the remaining \$63,127.

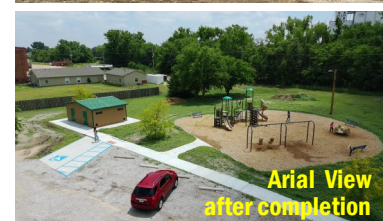

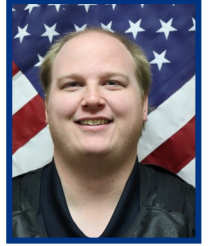
